# **RATE RSG (RESIDENTIAL SERVICE GENERAL)**

### 1. Availability:

For all single-family residential customers and all multi-family residential customers where the number of dwelling units is five (5) or less, where the use of natural gas is for other than space heating. Residential customers where the number of dwelling units is five (5) or less and use natural gas for space heating will be served under the Company's Rate RSH (Residential Heating Service) tariff.

### 2. Definitions:

- (a) The term "Delivery Service" shall mean the physical act of moving natural gas across the Company's distribution system to a customer's facility.
- (b) The term "Supply Service" is defined as the activities associated with the supply of the natural gas supply only.
- (c) Customers in this Rate RSG are defined as (1) Residential customers single family residential houses; (2) multiple dwelling residential buildings – detached multi-family residential such as a three family home; and (3) group dwelling projects – attached residential dwellings with multiple residences that do not qualify for Rate RMDS such as a condominium with separate metering.

### 3. Rate per Month:

(b) Supply Service:

- i. Supply Charge: Established monthly in accordance with and pursuant to the Purchased Gas Adjustment Clause as approved by the Authority.
- ii. Sales Services Charge: \$0.0183 per Ccf

#### 4. Minimum Monthly Charge:

\$20.35

### 5. Payment:

Bills will be rendered monthly and are due and payable upon presentation.

### 6. Delayed Payment Charge:

Bills not fully paid within twenty-eight (28) days of the billing date shall be subject to interest charges on the unpaid balance at the rate of 1.25% per month. Customers qualifying as hardship accounts shall not be subject to this provision.

#### 7. Service Regulations:

The Company's Service Rules and Regulations shall apply to service under this Rate RSG, to the extent not inconsistent with the terms and conditions of this rate RSG. Bills less than 28 days or more than 34 days will be prorated.
